The U.S. Economic Development Administration's STEM Talent Challenge **aims to build STEM talent training systems to strengthen regional innovation economies.** The FY21 STEM Talent Challenge will deploy a total of \$2 million in grants to organizations that are creating and implementing STEM talent development strategies that complement their region's innovation economy.

Competition applicants may request up to \$250,000 for implementation of a 24-month program.

The STEM Talent Challenge seeks applications for projects that use work-based learning models to expand regional STEM-capable workforce capacity and build the workforce of tomorrow.

Competitive projects should clearly align training activities with the talent needs of regional employers, leading to an increase in high-wage, high-growth employment opportunities with innovation-driven businesses and in industries of the future. Projects should clearly indicate how workers will be prepared for employment. This project will reconstruct I-70 through the City of Zanesville and resurface I-70 between U.S. 40 and State Route 93.

Full reconstruction will begin west of the Licking Road overpass, include the Maple Avenue ramps, and end east of the abandoned railroad overpass.

The project will impact 16 bridges along the downtown corridor, including bridges over the Licking and Muskingum Rivers.

Once completed, this project will not only provide aesthetic upgrades to the Zanesville Community along the I-70 corridor, it will also create a safer route for commercial traffic.
