

The large site at the rear of the photo is now home to Halliburton, and the site in the foreground is now home to AMG Vanadium. Behind Bimbo Bakery, The Bilco Company and TRP Zanesville now have their facilities.



**Today:** With construction under way on the new AMG Vanadium facility, the Eastpointe Business Park is near capacity. Current tenants include Avon, Bimbo Bakeries, Bilco, Halliburton, and TRP Zanesville. A rail transfer station is also located in the park.
